Comment: The Location has had signage changed to indicate Foundation ownership. One unlined pit. Small produced water tank, capacity unknown connected to separator is at grade within dirt SPCC. It is tilted, probably due to some subsidence. Adjacent pit (overflow?) ~14'x14'x2'deep is fenced, bermed and covered with steel mesh and netting at ground level. There is some water in the pit and some vegetation. It is unknown if water is PW or snowmelt. No indications of a release from wellhead, separator, or around pit such as staining, odor, free liquids or stressed vegetation.
