The well was SI and PB to offset HZ frac. Form 4 (6mo) was filed 11/11/2014 (Doc #400728907). The well is closed to the atmosphere via valve and the "Temporary SI for HZ Prep" sign is attached to the master valve. We are requesting continued TA status to evaluate future recompletion potential. MIT completed 5/20/2014.
