East Cheyenne Gas Storage, LLC recently observed bradenheads pressure increase at the ECGS 6-18 WP-D011-2 well. A COGCC Form 27 was filed December 23, 2015. Subsequently, cased hole logs were run & two cement squeeze zones were identified that would shut off any vertical migration of gas from the Dakota D storage intervals. Two cement squeezes are recommended:
Squeeze 1: Perforations 5105-5107 ft; Bridge Plug set at 5150 ft; Cement Retainer set 5050 ft; Cement amounts will be determined by pre-squeeze pump-in tests.
Squeeze 2: Perforations 3550-3552 ft; Bridge Plug set at 3600 ft; Cement Retainer set 3500 ft; Cement amounts will be determined by pre-squeeze pump-in tests.
Susequent well monitoring of pressures will be done to determine if squeeze jobs were effective.

Subsequent monitoring of bradenheads pressures indicates the repair of the well was successful.
