COMMENTS:

In accordance with COGCC Rule 907 for the management of exploration and production (E&P) waste, Encana collects representative samples of potentially impacted material on each of its locations for the purpose of comparing constituent levels to the allowable limits identified by the COGCC. All samples collected on behalf of Encana's Parachute Field Office are collected and documented in accordance with the Environmental Department's Sampling Procedures. Area background samples are also collected to establish a baseline for naturally occurring concentrations/levels for applicable constituents of concern. Field sampling documentation and laboratory reports not provided with this form are kept on file at the Parachute Field Office and are available upon request. Report of work completed is on date of sampling event that clears impacted soil.

2/19/15

During excavation of the unknown pit, impacted material was encountered approximately 5' below ground surface. Two grab samples were collected and laboratory results identified Total Petroleum Hydrocarbons [TPH] to be above the COGCC table 910-1. The material was blended with fertilizer, buried and capped with native fill. The pit area size was unknown so excavation halted until a drill rig could delineate the area.

03/23/15 – 03/25/15

The location was revisited with a drill rig to delineate the area. The impacted area was very small and segregated below surface. Three (3) aeration vent wells were installed within the original area and several more borings were drilled to collect samples surrounding the area.

05/04/16

The location was visited to resample the area of concern. A powered soil auger was used to get to depth and a soil sample was collected via hand auger. The laboratory confirmed that after blending and aeration the impacted area is below the COGCC 910-1 limit.

Lab reports also identified Sodium Absorption Ratio [SAR] to be above the COGCC 910-1 table. Consistent with reclamation objectives and approved handling of material with high levels of SAR, the impacted material was covered by more than three feet (3') of clean native fill and topsoil during backfilling operations. Lab reports also identified arsenic to be above the COGCC table 910-1, but are within the background limits of the area. This Sundry is being submitted as the Notification of Completion for Remediation # 9448. If the information provided is satisfactory, please provide a letter of No Further Action (NFA) and documentation of the closure for this remediation project and pit.
