Drilling/Completion Operations	Promptly report spills that affect wildlife to the CDOW. Limit parking to already disturbed areas that have not yet been reclaimed.
Wildlife	Enforce policies to protect wildlife (e.g., no poaching, no dogs on location, no feeding of wildlife, etc.)
Interim Reclamation	During drilling, production and reclamation operations, all disturbed areas will be kept as free from undesirable plant species as practicable.
Site Specific	Use existing roads where possible to avoid erosion and minimize the land area devoted to oil and gas operations. Restrict oil and gas activities as practicable during critical season periods.
Planning	Adequately size infrastructure and facilities to accommodate both current and future gas production. Avoid constructing any road segment in the channel of an intermittent or perennial stream. Combine utility infrastructure (gas, electric, water) planning with roadway planning to avoid separate utility corridors. Where possible, consolidate pipeline and existing roadways, or roadways that are planned for development.
Final Reclamation	Seed during appropriate season to increase likelihood of reclamation success. Do not include aggressive, non-native grasses in reclamation seed mixes.
Construction	Surface roads to ensure that the anticipated volume of traffic and the weight and speed of vehicles using the road do not cause environmental damage. Use minimum right-of-way width and vegetation mats where pipelines cross riparian areas and streams wherever possible.
