COGCC discussed the need to conduct interim reclamation so that the surface owner can utilize the adjacent pasture and to establish perennial vegetation that will out-compete weeds. Weed control plan has been received and processed. Inspection status will remain "Action Required" until weed assessment is made during the growing season to determine the success of weed treatment program and interim reclamation has been conducted.
