1	Drilling/Completion Operations	One of the first wells drilled on the pad will be logged with an open hole resistivity log and gamma ray log from the kick off point to into the surface casing. All wells on the pad will have a cement bond log with gamma ray run on production casing (or on intermediate casing if production liner is run ) into the surface casing. The horizontal portion of every well will be logged with ameasured-while-drilling gamma ray log. The form 5, completion report, for each well on the pad will list all logs run and have those logs attached. The form 5 for a well without open hole logs shall clearly state "no open hole logs were run" and shall clearly identify (by API#, well name & number) the well in which open hole logs were run.
