COMMENTS:

The Sater 12-19U saw communication while we were on stage 15 of the SATER 19J-443 API 123-42061 frac, the initial pressure read 150 psi, a pumper was immediately dispatched and proceeded to blow down the bradenhead through the flow line into the production tank. The bradenhead pressure had risen to 620 psi. It was then opened to the tank, immediately blew down to zero PSI, flowed mostly fluid some gas. The decision was made to leave BradenHead open on blow down to production tank, produced approximately 147bbls of fluid from 6/18/16 to 6/21/16 up the bradenhead. We have 24 hour personnel on location monitoring this Braiden head and will continue to monitor this well until the Completion of the offset pad is complete.
