#### COMMENTS:

The bradenhead monitoring equipment (installed 2-Jun-16 09:00) recorded approximately 975 psi for approximately 9.5 days before pressure was bled down. After bleeding down the surface casing to 425 psi, the pressure immediately increased to 896 psi. Kerr-McGee respectfully requests 30 days to conduct further analysis to accurately identify the cause of the pressure rise. Please see the attached graph for a depiction of events.
