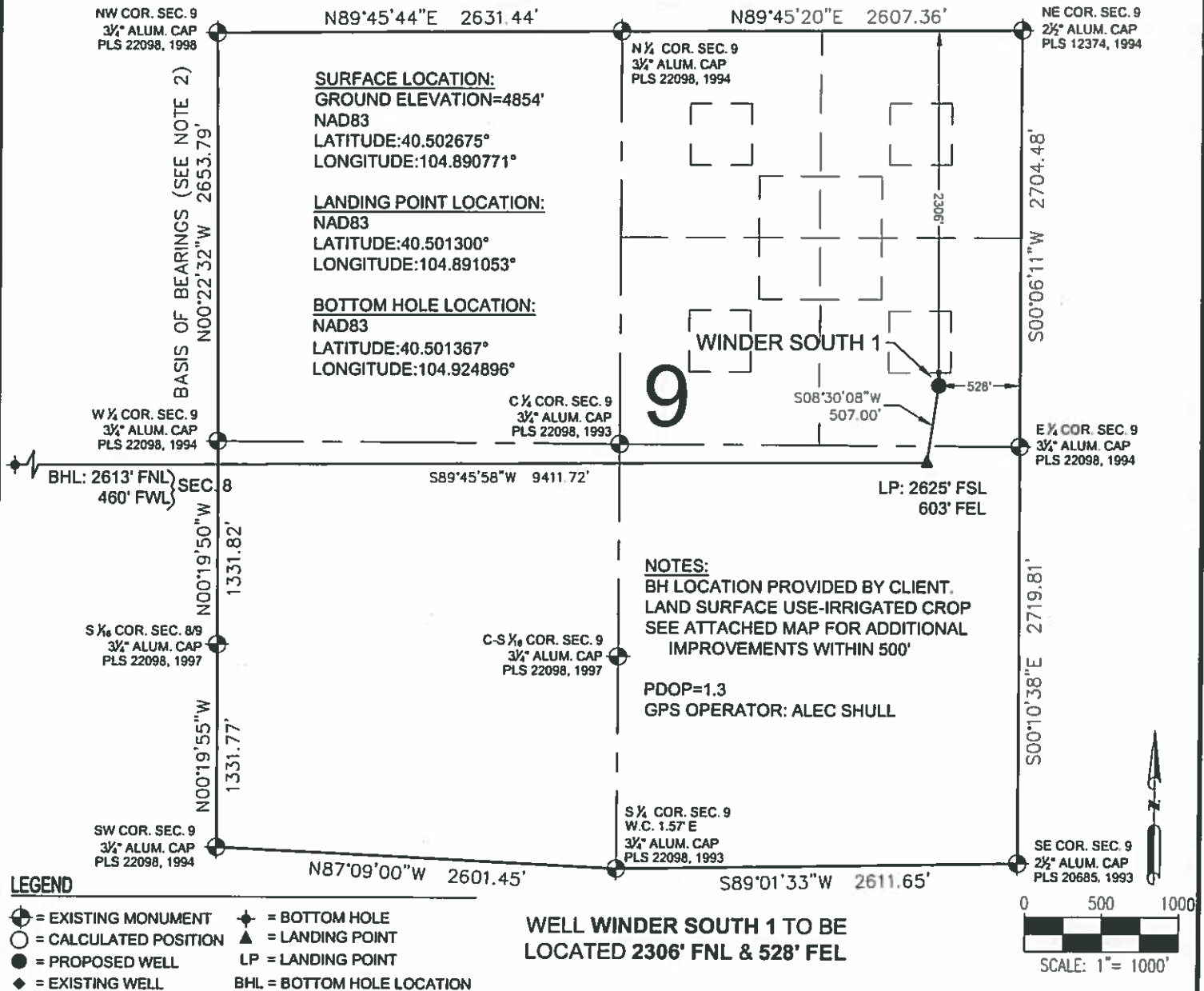


WINDER SOUTH 1 WELL LOCATION CERTIFICATE

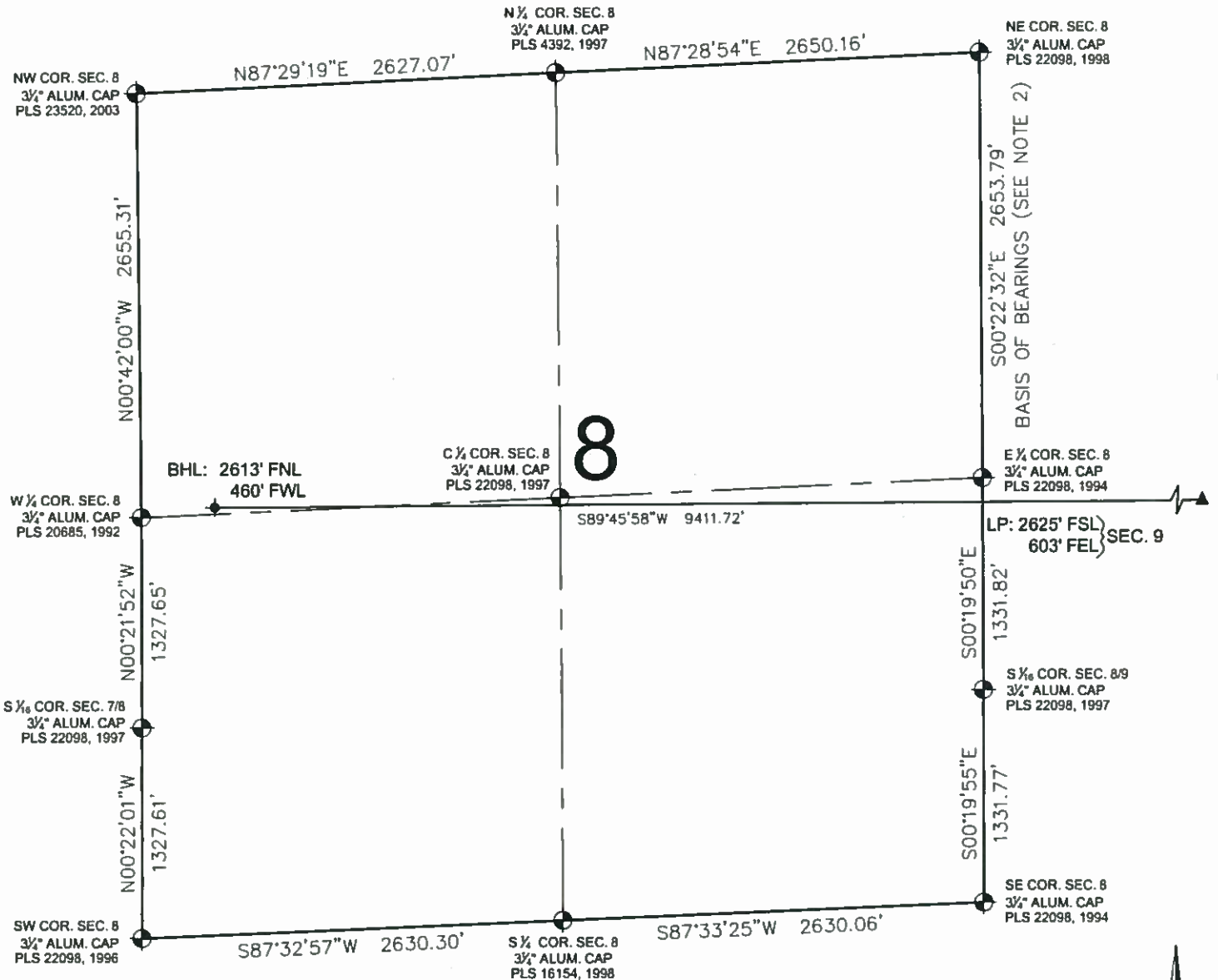
