Well was originally shut-in for Horizontal Safety Prep. CIBP W/SAND CAP @ 6,882 AND CIBP W/SAND CAP @ 6,851. A mechanical integrity test was performed to ensure integrity of the casing on 06/14/16. The well will continue to be shut-in for the next 4 to 5 years waiting for an engineering review. T&A status provided via a down-hole plug and surface isolation provided via closed master valve.
