4. TIH with casing cutter. Cut 4 1/2" casing at 5000'. Recover 4 1/2" casing.
5. TIH with tubing to 5050'. RU cementing company. Mix and pump 380 sxs 15.8#/gal CI G at 5050'.
6. TIH with tubing to 570'. Mix and pump 220 sxs of 15.8#/gal CI G cement down tubing. Cement should circulate to surface.
7. Cut surface casing 6' below ground level and weld on cap.
