When tripping in the hole to run drill pipe conveyed logs, we were unable to get past 10,006'. We came out to do a clean-up run with a roller cone bit. During that run we could not get past 9,360' and ended up twisting off leaving the bit, bit sub, float sub, 1 jt of HWDP, and 2 jts of DP in the hole.
