Noble Energy Inc. intends to drill this well as a monobore. The surface casing is set to 1850' to cover the base of the Pierre Aauifer for OBM considerations. Surface cement will be 535 sx of 1.70 ft3/sk slurry. No intermediate casing will be ran. The production string will be:  
Hole size will be 8-1/2"  
5-1/2" 20# P-1101C BTC casing from TD to surface  
605 sx of 12.0 ppg 1.8 ft3/sk lead and 1210 sx if 13.0 ppg 1.9 ft3/sk tail  
Oil Based Mud will be planned for the production hole interval only.  
Noble is changing the planned TPZ for this well and has renoticed the appropriate parties. The SHL, BHL, and spacing unit do not change. Revised plat and directional plan attached.
