It appears a seeding attempt was made but gravel was not removed preventing proper vegetative establishment.</p> <p>2) All debris and surface equipment shall be removed within three months of plugged a well.</p> <p>Refer to attached photos in Document #682400927.</p> <p>Provide an agreed upon schedule of reclamation operations, and documentation that debris and unused equipment have been removed to an attached Form 4 by CA date of 8/8/16, assigned to Chris Binschus.
