Extraction Oil and Gas, LLC (Extraction) has drilled the above referenced well in accordance with the provisions set out in Colorado Oil and Gas Conservation Commission (COGCC) Rule 318A.e. The well was drilled approximately 50' short of the proposed bottom hole, thus contracting the original wellbore spacing unit. Extraction's contracted Proposed Spacing Unit consists of:

SW¼ of Section 13, Township 2 North, Range 68 West  
NW¼ of Section 24, Township 2 North, Range 68 West  
Containing 320.00 acres, more or less

Extraction sent a courtesy notice to all the owners within the spacing unit as their right to object did not change. Copies of the required notification letters are on file at Extraction's office.

The Bottom Hole Location for this well changed from 2220' FNL, 1520' FWL, to: 2170' FNL, 1529' FWL, Section 24, T2N, R68W, 6<sup>th</sup> P.M.

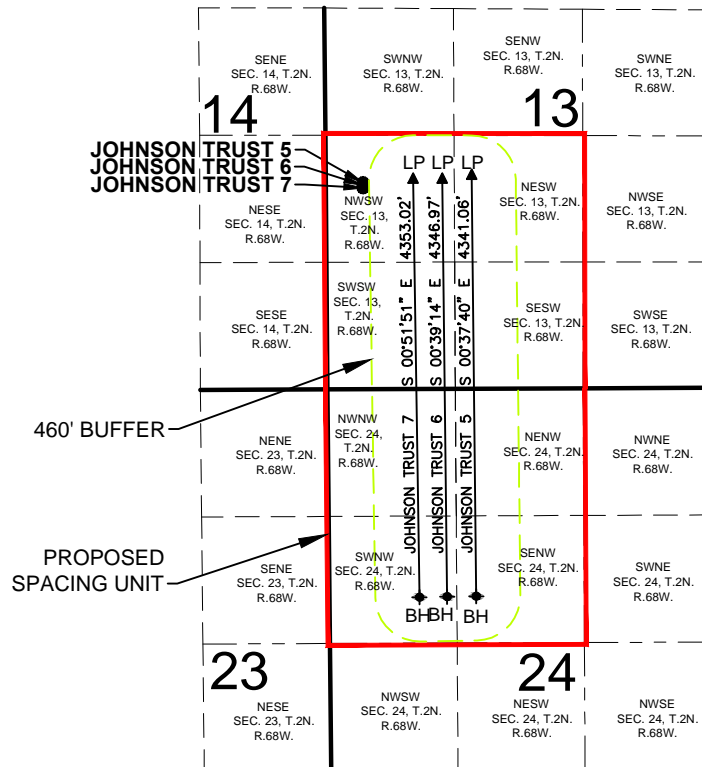

SEC. 13: SW4

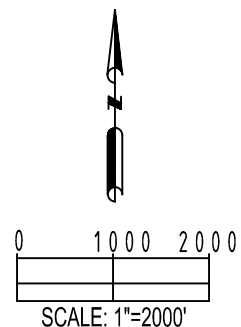
