Witcher #1-29 Well
NE/4 SW/4 Section 29-T34S-R42W
Baca County, Colorado

Dear Mr. and Mrs. Witcher:

This letter is entered into to set forth the agreement between you, as owners of the surface, and Cholla Resources, Inc. ("Cholla") as the operator of the Witcher #1-29 Well to be located in the NE/4SW/4 of Section 29-T34S-R42W, Baca County, Colorado.

You own the surface of 13,472 acres, more or less, in Townships 34 and 35 South, Ranges 42 and 43 West, 6th P.M., Baca County, Colorado, more particularly described on Exhibit "A" attached hereto and made a part hereof. In consideration for total and complete access to the surface damages for each and every well drilled on these lands by Cholla, its successors and assigns, Cholla agrees to carry you to casing point on each well drilled on these lands to the extent of an undivided five percent (5%) working interest. At casing point, you will have twenty-four hours from verbal notification by a Cholla representative in which to elect to participate for your five percent (5%) share in the attempt to complete the well as a producer of oil and/or gas. If you elect to participate, you will be obligated to pay your five percent (5%) share of all costs from casing point forward, including, but not limited to, completion and operating costs if the well is a producer or plugging and abandonment and surface restoration if the well is a dry hole. After casing point, all operations will be conducted in accordance with the terms and provisions of the Operating Agreement attached hereto as Exhibit "B".

Once the well is completed or plugged and abandoned, you will be assigned your five percent (5%) share of the acreage earned by Cholla under the terms of the Farmout Agreement dated October 1, 1993, between Cholla and Axem Energy Co. and a like interest in all oil and gas leases owned by Cholla in the prospect area. The "prospect area" is defined as Section 20, 21, 22, 28, 29, 30, 31, and 32, T34S-R42W, Baca County, Colorado. A copy of the Axem agreement is enclosed for your reference.

If the well is completed as a producer of oil and/or gas, you will receive your five percent (5%) share of revenue from the well, less your share of the landowner royalty and overriding royalties burdening the drillsite lease. On the Witcher #1-29 well, those burdens total 20.75%. As a result, your revenue interest in the well will be $5\% \times 79.25\% = 3.9625\%$.


You agree that by Cholla paying your five percent (5%) of costs to casing point, Cholla will have fulfilled its complete obligation to you for surface damages for the Witcher #1-29 well and will have earned full, complete and continuous access over and across your lands for all future operations. On all subsequent wells drilled on your surface, Cholla agrees to carry you to the extent of a five percent (5%) interest to casing point in lieu of the cash payment of surface damages for the well location.

For all wells drilled in the Contract Area as described on Exhibit "A" to the Operating Agreement attached hereto but not on your surface, you will have the right to participate for your five percent (5%), working interest in the drilling, completion or plugging and abandonment of the well by paying your five percent (5%) share of all costs associated with said well. All such operations will be subject to the terms and provisions of the Operating Agreement attached hereto.

For all wells drilled on your surface, Cholla agrees to fence each wellsite and re-seed all areas disturbed by the drilling and completion operations and not needed for producing operations. Cholla also agrees to consult with Dan Witcher on the location and size of all access roads for producing operations.

If the above correctly sets forth the agreement between us, please so acknowledge this agreement in the space provided below and return one copy to Cholla for its files.
