## COMMENTS:

Bill Barrett Corp. is submitting this sundry to provide final analytical data and request closure approval for BBC's Moser Sec. 4-2-65 Beneficial Reuse Area. BBC will no longer utilize this site for spreading mud & cuttings.

### Closure information:

LT Environmental, on behalf of BBC collected four composite soil samples from the spreadfield. Each composite consisted of 3 discrete soil samples collected from 0 to 8" below ground surface. Sample collection locations are shown on Figure 2.

Arsenic concentrations of the soil samples ranged from 0.97 to 1.65 mg/kg. The arsenic concentrations of all soil samples exceeded the COGCC Table 910-1 allowable arsenic concentration of 0.39 mg/kg. Background arsenic concentrations that exceed the COGCC Table 910-1 standard are not uncommon within the region. Background concentrations for Colorado have been observed to range from 0.3 mg/kg to 26 mg/kg (Severson, R. C., and Tourlet, H. A., Assessment of Geochemical Variability and a Listing of Geotechnical Data for Surface Soils of the Front Range Urban Corridor: U.S. Geological Survey Open-File Report 94-648, 1994). Additionally, the U.S. Environmental Protection Agency (EPA) Region 8 conducted a study of background arsenic concentrations within Colorado. A total of 2,700 soil samples were collected from 44 counties in Colorado. Sample areas included native grasslands, agricultural areas, urban mixed land use, and mining. This study concluded that the average background arsenic concentration in Colorado native grasslands, rangelands, and agriculture, which is similar in land use to the Site, ranged from 3 to 14 mg/kg, and the average arsenic background concentration for all land uses in Colorado was 11 mg/kg (Arsenic Concentrations in Soil, Risk Management Guidance for Evaluating: Colorado Department of Public Health and Environment, July 2014). The arsenic concentrations observed within the spreadfield area at the Site were within the range of the average background concentrations for native grasslands, rangelands, and agriculture and below the average arsenic background concentration for all land uses within the region. Soil analytical results are provided in Table 1.
