PROPOSED UNDERGROUND INJECTION CONTROL PERMIT

PROPOSE OF PUBLIC NOTICE:

The purpose of this notice is to solicit public comment on the Decker 22-18 #2 disposal well, a Class II injection permit submitted by Diamond Operating Inc. The Decker 22-18 #2 is an existing oil and gas well being converted for disposal. The well was drilled at a location 1991 feet from north line and 2058 feet from west line of SENW of Section 18, Township 4 South, Range 53 West, 8th P.M., Washington County, Colorado.

BACKGROUND

Class II injection wells are permitted and regulated in such a manner as to prevent the contamination of underground sources of drinking water and to ensure fluid emplacement and confinement within the permitted injection zones. Class II injection wells are permitted to inject waste generated from oil and gas exploratory and production operations. Diamond Operating Inc. proposes to inject these fluids into the J-Sandstone of the Dakota Group at depths of between 4,544 and 4,648 ft in the Decker 22-18 #2 well through a cased-hole completion.

Public comments are encouraged and will be accepted, in writing at the Commission for a period of thirty (30) days after publication of this notice. If any data, information, or arguments submitted during the public comment period appear to raise substantial questions concerning proposed injection well permit, the Director may request that the Commission hold a hearing on the matter.

Additional information on the operation of the proposed injection well may be obtained at the Commission office.
