

Surface Use Agreement For Underground Injection Well

THIS AGREEMENT is made this 16th day of November, 2015, by and between **Scott and Delana Harrison**, of 7649 S. Eaton Way, Littleton, CO 80128, (hereinafter referred to as "GRANTOR") and **Diamond Operating, Inc.**, of 6666 Gunpark Drive, Suite 200, Boulder, Colorado 80301, (hereinafter referred to as "DIAMOND").

Surface Use Grant: For and in consideration of the sum of Five Hundred Dollars per year (\$500.00/year) for so long as the wells remains in use, GRANTOR hereby grants, bargains, sells and conveys to DIAMOND a permanent right-of-way and easement to construct, maintain, and operate a water disposal well to be used for the disposal or injection of produced water, in the Earnest Decker #2 well located in, on, and over the following described land, of which GRANTOR is the surface owner, situated in Washington County, Colorado, and hereinafter described to-wit:

SE¼ NW¼ of Section 18-T4S-R53W

Said facility easement shall include less than 1/15th of an acre adjacent to the well and a 10' wide, limited-use access road that will be used primarily for well maintenance access. All pipelines to and from the facility under this grant shall be buried to a depth of at least three (3) feet. GRANTOR allows ingress and egress to and from said facility for any and all purposes necessary and incident to the exercise by DIAMOND of the rights granted by this contract.

This agreement shall be binding and inure to the benefit of the heirs, representatives, successor and assigns of the respective parties hereto.




