Performed bradenhead test on 4 well pad pre completion. Initial bradenhead pressure 700 psi, gurgled clear water initially then blew down to 20 psi and shut in for 24 hours. No casing pressure during testing. Returned to test pressure built to 420 psi blew down to 5 psi and shut in. PDC will plumb the bradenhead to a tank for 7 days and re-test. Where gas volumes are sufficient to support combustion, and production facilities are not yet constructed onsite, gas will be flared upon approval from COGCC. Gas analysis submitted to COGCC 6/15/2016.
