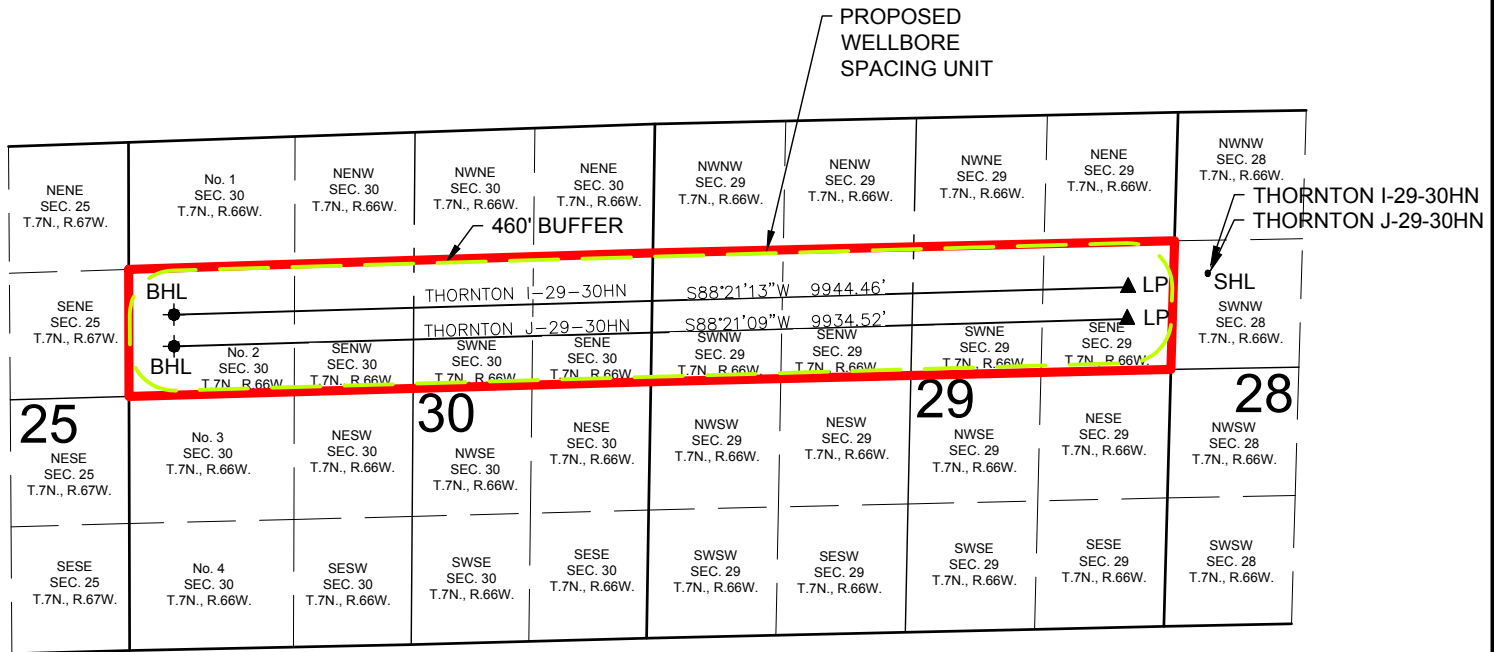

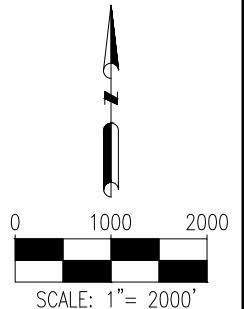
THORNTON 28-H PAD
