Comments

We had another issue on the Winder #2. While drilling ahead 9' below our geo targets we saw a gamma spike and the hole proceeded to grab us. After pulling free and awaiting bottoms up we saw shale coming over the shakers. This indicates our throw was much larger than expected. We were anticipating this throw, however, it was much larger than the offset well we already drilled.

With your permission we would like to open hole sidetrack (no cement) at 7,805', this will allow us to shift targets even lower and prepare for this throw.
