COMMENTS:

We have addressed the items listed on the COA for Doc. 677900105. It is apparent that after ongoing landfarming that more work is necessary in order to meet the Table 910-1 standards. Therefore, LINN requests to continue landfarming thru 2017.

NOTE: We found that there is very little reduction in the level of the contamination that occurs in a three month timeframe, especially over the winter months. For that reason, and due to the high cost associated with sampling and testing, we have elected to take fewer samples. We have modified the plan this year to add larger quantities of phosphorus at each treatment and will have treated the material four times by the end of the summer. At that time we will sample and test. We recently completed treatment #2. Our last sample was on 10/2/2015 and Benzo (a) pyrene was very high – 0.0594; the threshold is 0.022. We are confident these levels will continue to drop with additional treatment.
