BLM issued Caerus a "Notice of Written Order" stating, "atmospheric pressure associated with all wells on the 8D pad is not consistent with the elevation found in the calibration reports...Note: gas paperwork consistently uses the AP of 11.5. This does not correspond to the elevation found on documentation which is 6,407 which is not consistent with the APD elevation".

The correct "final graded" elevation is 6,342.8' for this well.
