Inspection Doc. #200089436 identified a large hole that had formed on location that needed to be repaired. Large hole still exists on location, refer to figures 2-5 in the attached document. A large, unvegetated area exists on the slope of the south end of the location. Previous records suggest area is a result of a salt kill due to a produced water spill. Phone conversation with Mr. Unruh from Oilfield Salvage & Service CO confirms that a "salt water spill had occurred", and that "though work had been done, it does not appear to have took".	trujilloam	08/04/2016
