Ward Petroleum requests to extend the flaring period until January 9th, 2017 to utilize new equipment that will strip out the NGLs from the gas stream, reduce the flare volume and potentially allow Ward to sell the dry gas to heat residential homes. During this period Ward Petroleum will utilize Pioneer Energy's mobile alkane separator to reduce and potentially eliminate the flare altogether. To accomplish this Ward will set one bullet tank onsite and have two mobile alkane gas separator units onsite.
