#### COMMENTS:

In July 2015, the Weber Federal 32-04 was shut-in due to an integrity management issue with the production tanks. The tanks were then removed from the location. Over time, the wellhead seals were unable to contain the well pressure, so rods and tubing were pulled from the well and a CIBP set at 6214' and pressure tested to isolate perfs from 6288-7570 in the Niobrara formation, October 8, 2015. The wellhead was removed and replaced with a cap flange.

After conversation with Dave Andrews with COGCC the well status is considered temporarily abandoned.
