Synergy Resources would like to request to have OBM for all wells on Williams Pad. Reason for this change: OBM helps with lubricity thereby decreasing torque and drag enabling better weight transfer to the bit particularly in longer laterals or extended stepouts on larger pads. In addition, OBM inhibits highly reactive shales from swelling which leads to better wellbore stability and decreases the chances of sloughing formations, packing off or stuck pipe. Please note the Waste Management Plan has been attached to this sundry for the location as well.
