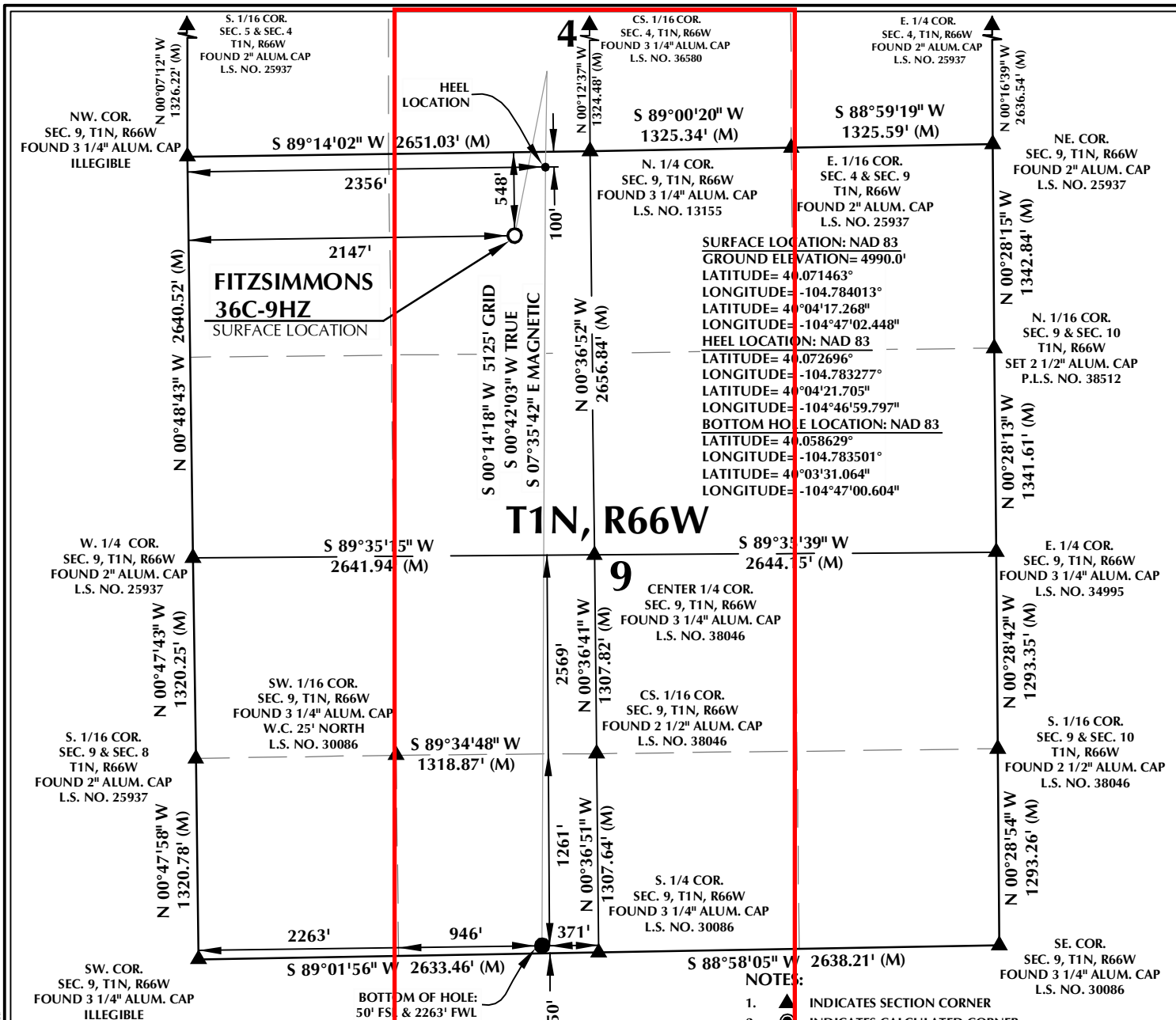

# PROPOSED SPACING UNIT



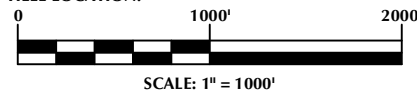

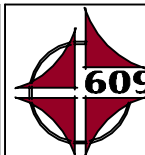
