## COMMENTS:

Noble Energy intends to drill this well as a monobore using Water Based Mud in the drilling program. No intermediate casing will be run. The surface casing will be set to cover the base of the Pierre Aquifer for Oil Based Mud considerations. Oil Based Mud will be planned for the production hole interval only. Noble Energy shall isolate both the Fox Hills and Upper Pierre Aquifers with surface casing from hydrocarbon bearing zones and exposure to oil based drilling fluid. Noble Energy also agrees to not expose the Upper Pierre Aquifer to oil based mud. All cuttings will be taken to a certified disposal.
