COMMENTS:

During recent workover efforts, BP believes that a hole was created in the tailpipe of the existing permanent packer while removing scale in an attempt to set an isolation plug. This tailpipe is part of the permanent packer assembly and limits our ability to pull tubing and redress seals without killing the well.

BP requested and obtained verbal approval on 8/22/16 from Mr. Bob Koehler to leave the existing packer in place and set a new permanent packer above it in an effort to preserve future workover flexibility and avoid the risks of damaging the casing or creating a restriction by attempting to mill out the current packer

The new packer setting depth of ~3855' is ~25' above the existing packer in the well and ~171' above the top perforation. The packer setting depth conflicts with the requirements of 326.a.(1).A which requires that a packer be placed within 100' of the top perforations when conducting a mechanical integrity test. As a result, BP is respectfully seeking a variance to this rule pursuant to Rule 502.b for the reasons stated above (see attached letter).
