COMMENTS:

COGIS lists Pit Facility #114431 at the Marlatt tank battery under Macey & Mershon Oil Inc. (Operator #52225). This was based on a COGCC inspection report dated 5/16/1985 which indicated a 4' diameter vertical culvert pipe, commonly referred to as a "tinhorn". A COGCC inspection report dated 9/12/1989 also indicated the presence of a vault culvert. Subsequently, Macey & Merchon Oil divested this facility to Tower Energy (Operator #89045) on 4/1/1990 and Tower Energy divested to North American Resources Co. (Operator #63800) on 1/1/1991. A COGCC inspection report dated 11/10/1994 did not indicate any culvert present and indicated No Pits. Subsequently, NARCO divested the facility to BATAA Oil (Operator #6570) on 12/1/1997; BATAA to Merit Energy (Operator #56565) on 4/1/2001, and; Merit Energy to PDC Energy on 6/30/2012. Therefore, the "tinhorn" appears to have been removed between 9/19/1889 and 11/10/1994 and prior to COGCC RULE 911. Operator Comments:

Pit Facility #114431 was identified as a "tinhorn" on several COGCC inspection reports and appears to have been removed between 9/19/1989 and 11/10/1994, prior to COGCC Rule 911. PDC Energy acquired the facility from Merit Energy on 6/30/2012. Subsequently, a leaking dumphine was discovered in 2014 during annual flowline test operations. Remediation was conducted and impacted soils were removed to a depth of approx. 13' below surface. Lab results of confirmation samples indicated contaminant levels below Table 910-1 standards. Subsequently, a Form 19 - Spill Release Report was submitted on 6/10/2014 with the remediation results and the spill has been closed (see Document #400624156). The remediation area at the Marlatt tank battery included areas in and around the concrete vault and former tinhorn location. As a result, PDC Energy respectfully requests closure of Pit Facility #114431 and that COGIS reflect a CLOSED status.
