1. MIRU RU pulling unit. Pull 2 3/8" tubing.
2. RU wireline company.
3. TIH with CIBP. Set CIBP at 6538'. Top with 2 sxs 15.8#/gal CI G cement.
4. TIH with casing cutter. Cut 4 1/2" casing at 875'. Recover 4 1/2" casing.
5. TIH with tubing to 925'. Mix and pump 120 sxs of 15.8#/gal CI G cement down tubing.
6. Reset tubing at 50'. Mix and pump 20 sxs of 15.8#/gal CI G cement down tubing. Cement should circulate to surface.
7. Cut surface casing 6' below ground level and weld on cap.
