The noxious weeds (Diffuse knapweed) have developed seed. These plants will need to be collected and removed to prevent further seed dispersal. Other control methods will need to be utilized and continued efforts must be performed to adequately control the noxious weed infestation.	CostaR	09/13/2016
Recommend recontouring the location to decrease the grade of the cut and fill slopes. This would reduce the susceptibility for erosion and can enhance the establishment of vegetation to achieve long term stabilization.	CostaR	09/13/2016
Establish vegetation with total perennial non-invasive plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture that matches the adjacent pastureland or a seed mixture requested by the landowner. Continue to monitor and manage this site until Final Reclamation has Passed.	CostaR	09/13/2016
