Comment: **This location does not meet reclamation regulations. Surface casing still remains on location. Location had not been recontoured and erosion evident on slopes on the west end of the location. Location has not achieved uniform vegetative cover.**

Corrective Action:

Date **11/30/2016**

Cut casing below surface. Recontour location and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture that matches the adjacent pastureland or a seed mixture requested by the landowner. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be complete no later than 11/30/2016
