Comments:

After the current agriculture crop has been harvested, PDC will implement the following corrective action plan to the former Schafter 2 wellhead location and tank battery facility as specifically mentioned in the COGCC August 22, 2016 inspection. To alleviate possible compaction concerns, PDC will rip the subsurface. After the subsurface has been ripped, the top 18" of soil will be removed and replaced with topsoil. By performing the above plan, this would ensure that there are no subsurface root barriers and/or soil nutrient concerns that would stunt future growth.

The Canada thistle (cirisium arvense) was observed on the property during the August 22, 2016 inspection. The thistle has already bloomed for 2016, therefore removing the plants will control future thistle growth. In the Spring of 2017 the thistle will be sprayed in early Spring 2017.
