PIONEER is requesting continued temporarily abandon status on the Beacon 11-18 well as it is not feasible to rework the well at this time due to current market conditions. A Form 4 for temporarily abandon status was submitted to the COGCC on 9/24/2015. A Mechanical Integrity Test dated 2/25/2014 has also been previously submitted. The Beacon 11-18 well is closed to the atmosphere via a wellhead secured and shut-in by a valve as well as a bridge plug set at 2740'.
