Comment: OGCC inspector was on location on 9/21/16 to investigate for Complaint# 200440346. OGCC inspector found no active leaks. Well documentation has a Form 42 for start of plugging operations dated 09/08/16. Well appears to have been plugged at the time of this inspection. Wellhead parts and casing are piled on the SE side of the pump jack. Any evidence of the spill provided in the photo from complainant has been removed as evidenced by scratch marks from a front loader (see photos). The source of the release is unable to be determined at his time. Photos of the location are attached to this report.
