Construction layout document with stockpile volumes is attached.
Straw wattles have been trenched, per directive on inspection. Trenches have destroyed native grasses, enlarged disturbance, and reduced effectiveness of sediment trapping abilities of wattles.
Wattles built as a J hook are in addition to the approved and permitted SWMP. Because they are of a additional nature, any size is adequate.
Please note that the Master SWMP for the Schulte Project is not set up, nor permitted, as a zero discharge facility. This location is permitted to discharge to the tributary of the Arikaree Creek and SWMP controls are designed as such, particularly for the potential run on waters.
Tracking was applied to all slopes and stockpiles. The sandy nature of the soil combined with the low moisture content in the area leads to the result showcased in the photos. Retracking of slopes will have a negative effect on stabilization and could possibly increase surface disturbance.
