General Comment:

On 9/27/2016, COGCC Environmental Staff, Kris Neidel inspected the spill location 447275, spill number 401092833. No remaining hydrocarbon impact was detected during the inspection. As seen in attached Photos, impacted soils have been removed from the spill path. The intermittent stream and siphon were free of fluid. Per document 401099835, operator should submit a Form 27 that documents the cleanup, of the spill path, root cause analysis, flowline testing, etc. Well 103-07274 was pumping at the time of inspection; location berm had been recently maintained.
