RRRH 6-1 was completed as a stratigraphic corehole, and there was no production of petroleum hydrocarbons at this location. Red River Ranch Holdings LLC has completed all final reclamation activities at this location, including backfilling of all pits, mouse and rat holes, and cellars; removal of all surface equipment; removal of all debris, rubbish, supplies, waste materials, risers, downhole materials, and other equipment; redistribution of stockpiled topsoil over disturbed areas, weed management; stormwater management; and revegetation. The location has been returned to its original land use of timber production.
