37.11543/-104.84404. Sediment was being deposited on the road and near the culvert. There was no outlet protection around the culvert which has resulted in erosion. There is an erosion channel which has developed along the main road.

We are requesting an extension of that due date to 11/21/16, as this location currently has restrictions for hunting and we are not able to conduct any work at this time.
