In early 2015, Encana Oil & Gas (USA) Inc. ("Encana") met with Colorado Oil and Gas Conservation Commission ("COGCC or Commission") to discuss approximately 58 of Encana's locations in need of interim reclamation ("Subject Locations"). During 2015, Encana completed interim reclamation for ten of the Subject Locations, pursuant to an email agreement between Encana and COGCC staff dated March 4, 2015. On February 4, 2016, Encana met with COGCC staff to discuss its plan for interim reclamation of the remaining Subject Locations. The delay in interim reclamation of the Subject Locations was due largely because of planned future operations. Encana is submitting this letter to formalize our Voluntary Disclosure under rule 523.e.(1) and request a 502.b(1) variance from the timing requirements of interim reclaim under rule 1003.b of the Subject Locations in the Piceance Basin. The request of this variance will not violate the basic intent of the Oil and Gas Conservation act including, but not limited to, the protection of public health, safety, welfare and environment. Encana has the appropriate surface use agreements in place for the Subject Locations and has and will continue to work with all effected landowners to insure that the timing of interim reclamation is mutually agreed upon.

The following documents, attached hereto and incorporated herein, outline the details of Encana's Compliance Program for interim reclamation of the Subject Locations:

- a. *Attachment 1 is a list of Subject Locations and a proposed schedule of interim reclamation per year to be finalized by 2019. COGCC Staff and Encana agree that this schedule may be modified by Encana as appropriate, but in no event shall Encana complete interim reclamation on fewer than 6 of the Subject Locations per year.*
- b. *Attachment 2 is Encana's Master Reclamation Plan for the Subject Locations in Piceance Basin.*

Encana will submit an annual report by December 30<sup>th</sup> of each year this agreement is in place, summarizing all interim reclamation completed during the previous calendar year. The following spring, an informational sundry will be submitted indicating Encana's plans for interim reclamation at the Subject Locations during the calendar year.
