General Comment:

Environmental inspection conducted on September 14, 2016 to observe the progress on the Terraces Project. According to the Plan proposed by Stantec on behalf of Chevron Environmental Management Company (CEMC), and approved by the COGCC, 1) A Final Site Assessment was proposed to be completed during the summer of 2016 to better delineate the extent and depth of the impacted terraces, and 2) Two terraces were going to be excavated, remediated and backfilled in 2016. The other five terraces will be remediated in 2017. Assessment was completed during the summer. Stan Spencer of the COGCC, Rifle office, was present during the boring and sampling event.

At this time, the lower two terraces (#6 and #7) have been excavated; impacted material was removed and taken to an approved landfill, and backfill has been completed with clean material. An access road was constructed to give access to the terraces. Final reclamation and reseeding will be completed after all terraces have been remediated.
