Ward requests 90 days to flare, after the 90 day period Ward will either shut the well in or use an alternative and approved method to eliminate excess waste. Ward will utilize an ECD and comply with COGCC rule 912. Ward will submit a gas analysis as soon as it is available and report the monthly flared volumes on a Form 7. Ward is installing it's own gas pipeline to the area and requests time to receive ROW, permits, and to construct the line.
