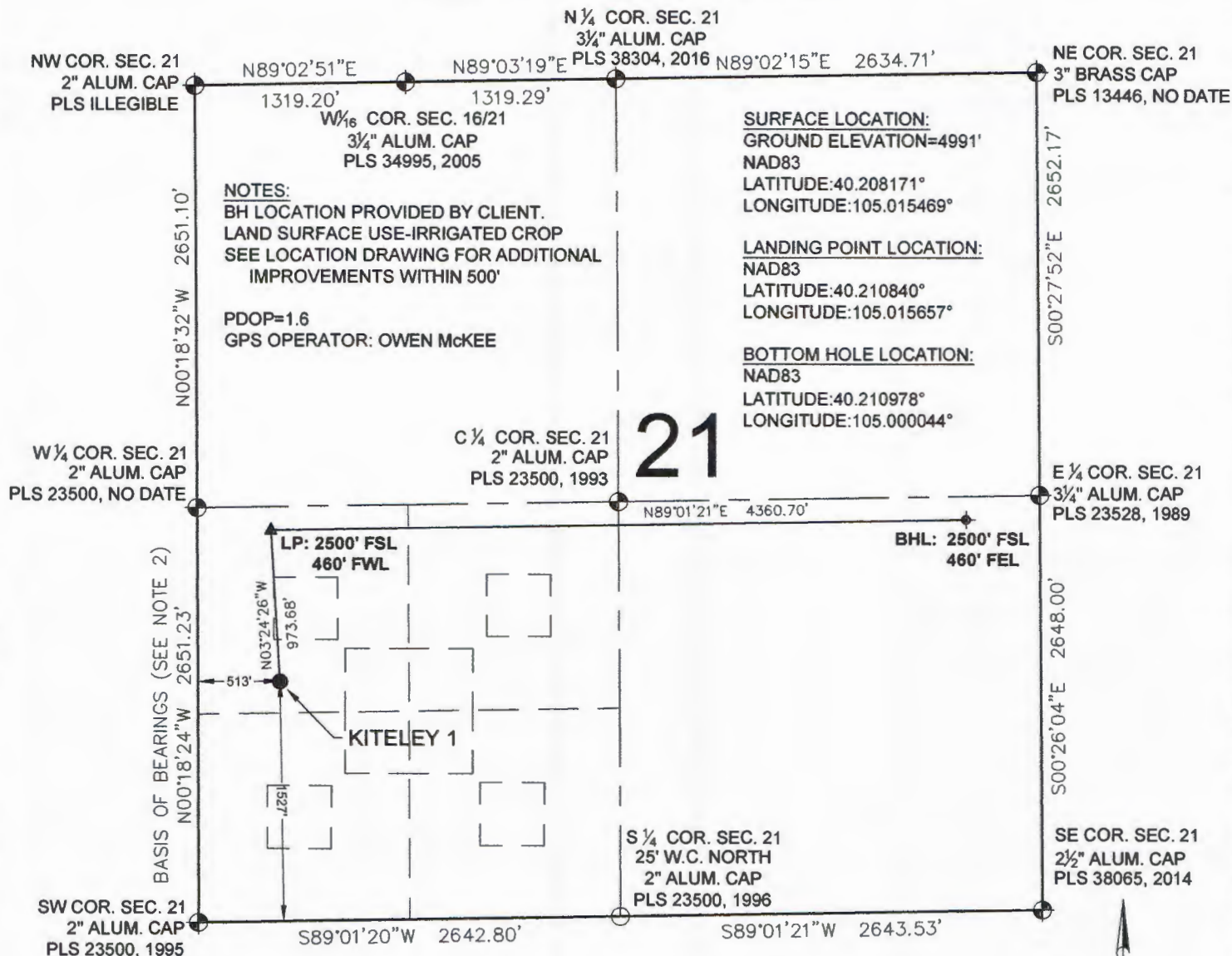


KITELEY 1 WELL LOCATION CERTIFICATE

WELL KITELEY 1 TO BE LOCATED 1527' FSL & 513' FWL

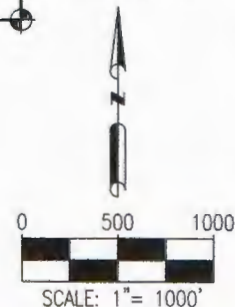
