The spacing unit is a 160-acre wellbore spacing unit for the Niobrara & Codell formations.

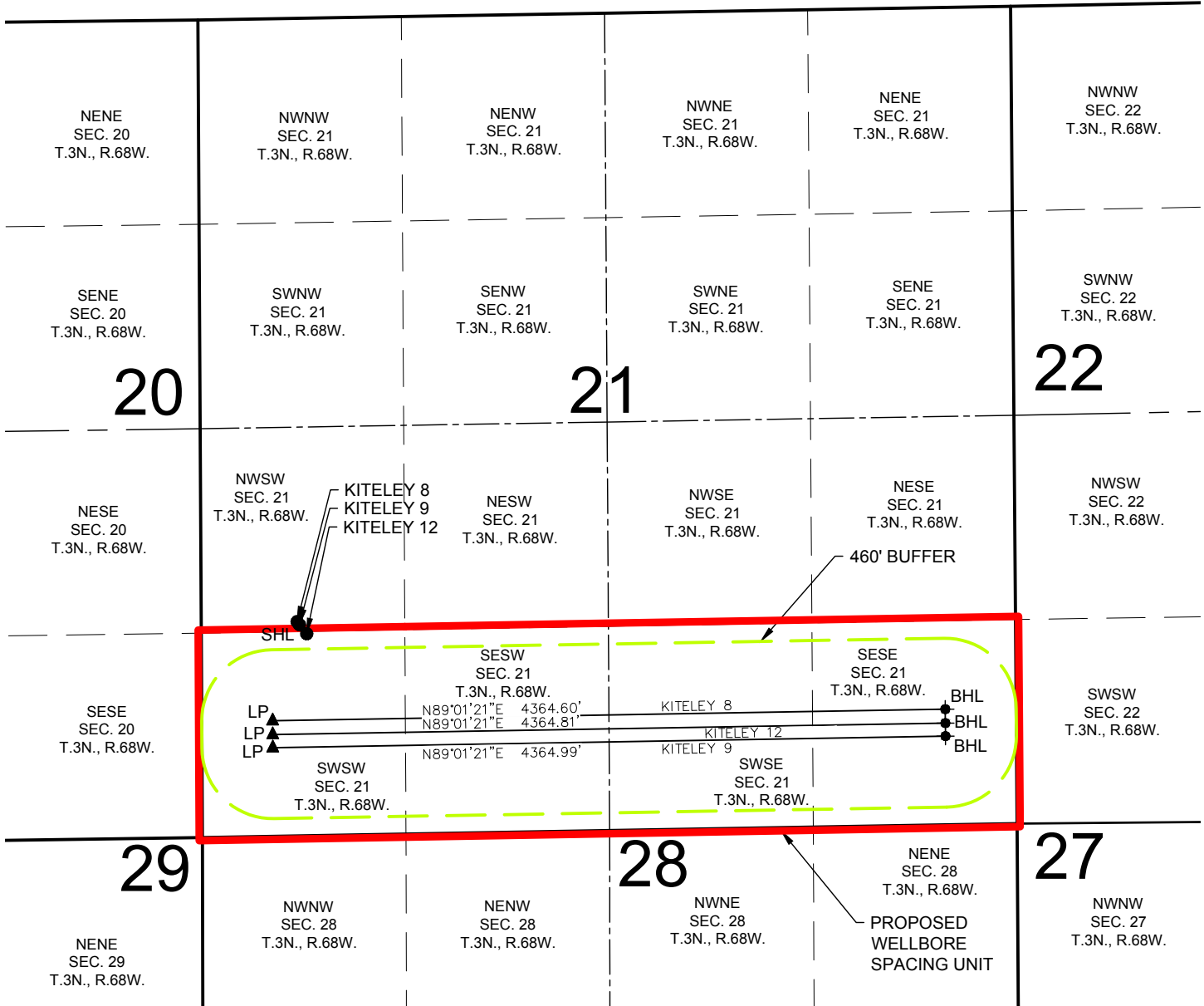

SEC. 21: S2S2**



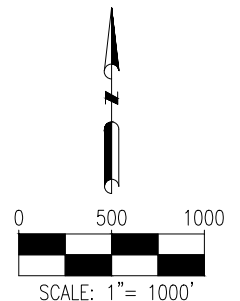
