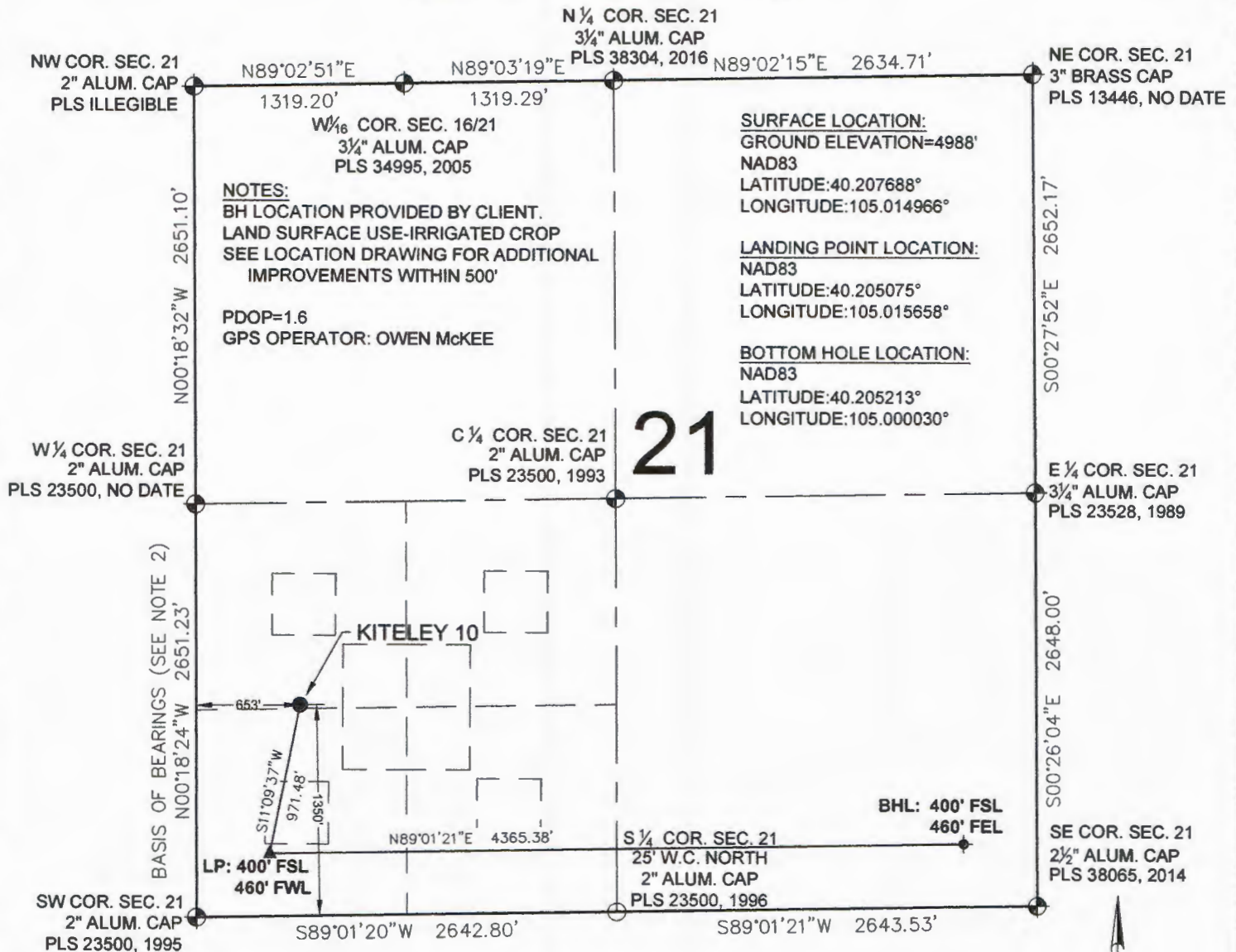


KITELEY 10 WELL LOCATION CERTIFICATE

WELL KITELEY 10 TO BE LOCATED 1350' FSL & 653' FWL

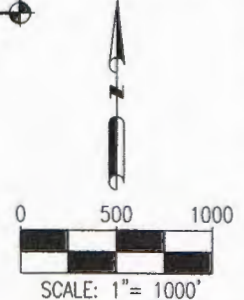
