Surface Location changed to limit total # of pads and reduce disturbance.

The Piceance 29-07 pad (#334436) is being amended to add 3 new well slots for the Piceance Federal 29-01W, Piceance 29-01E and Piceance 29-02E wells.

In addition, wells that were planned to be drilled from the proposed Piceance 29-11 (#444147) pad will now be drilled from the 29-07 pad. Six of these wells will have a new Form 2 and a new BLM APD submitted (listed on the Related Items tab); the remaining wells will have COGCC and BLM sundry forms submitted to change the SHLs and/or BHLs.

By not building the 29-11 pad and access road, surface disturbance will be reduced by approximately 12 acres. After the amended 2A and all associated Form 2s have been submitted, a Form 4 Sundry Notice will be submitted to AL the Piceance 29-11 pad."
